BOARD RESOLUTION No.018, Series 2021 dated July 17, 2021

A RESOLUTION recommending revival LIFE MEMBERSHIP of the NAMPAP, Inc. The main objective is to generate funds from the proceeds of the NAMPAP Inc. Life Membership Fee. Twenty percent (20%) of total collected life membership fees will be obligated to construct a permanent headquarters/ office building and to ensure organizational upkeep of NAMPAP, Inc. A Life Member will be recognized as a distinguished member of the organization and entitled to a twenty-five percent (25%) discount in all NAMPAP Inc. National Conferences and Conventions.

Whereas, in the past, "Life Membership" is among the membership status of the NAMPAP Inc. roster posted in NAMPAP, Inc. documents. However, in the current Constitution and By-laws of NAMPAP Inc., there is no provision for Life Membership. Therefore, there is a need for its revival.

With the organization's intent to guarantee the upkeep and construction/improvement of a permanent office building/space, the provided special discounts on organizations activities as above mentioned, the LIFE MEMBERSHIP status will be re-activated with the following provisions.

Interested and qualified NAMPAP Inc. members will pay a onetime Life Membership Fee following member's age:

- a. Good Standing Member 21-28 years old – Eighteen Thousand Pesos (P 18,000.00)
- b. Active Member 29-35 years old – Fifteen Thousand Pesos (P15,000.00)
- c. Active Member 36-42 years old – Twelve Thousand Five Hundred Pesos (P12,500.00)
- d. Active Member 43-49 years old – Seven Thousand Five Hundred Pesos (P7,500.00)
- e. Active Member 50-55 years old – Five Thousand Pesos (P5,000.00)
- f. Senior Active Member 56 years old and above – Two Thousand Five Hundred Pesos (P2,500.00)

A Regular Member to qualify for Life Membership shall have a minimum of three (3) years an active member of the organization and in good standing. The senior active members are those nearing senior citizen status to be recognized and awarded Honorary Status for their pursuit of the Master Plumbing profession and practice. The Professional Practice Committee shall consider another very interested member with a valid reason and support commitment to the organization. The amounts were computed to gain sufficient interest anticipating a standard yearly value of money inflation.

The Life Member status shall be considered a long-lasting support for furthering the organization's purpose to bring honor and prestige with the accomplishment of an established professional as stipulated within the Constitution and by-laws of NAMPAP Inc.

It is resolved that NAMPAP Inc. "LIFE MEMBERS" will be included in the re-activated roster and be given distinctive identification cards indicating the membership status. For the Journeymen and Associate members, identification cards shall be in green (fresh, energy, and growth), regular members identification cards shall be in blue (cool and expanse), and Life members identification cards shall be in blue with a "gold" bottom strip accent symbolizing a

sharing of wisdom, knowledge, and wealth to the organization. The Identification Cards as per BOARD RESOLUTION No.018, Series 2021 dated July 17, 2021, shall be valid for a period of five years, and should be renewed for the purpose of updating member's a profile/information/identification picture and issuance of a new identification card.

Life Membership is a National initiative, and the local chapters shall have no share in the Life Member fees collected. Though the members with its loyalty and involvement to its local chapter shall continuously pay local membership fee due for the purpose.

A separate bank account solely for proceeds of Life membership fees shall be made to ensure better fund management while saving for the desired NAMPAP Inc. Permanent Office/ Headquarters project. An amount equivalent to the member's annual dues shall be transferred from the life membership account to the general account upon yearly operation budgeting of the organization. Interest income accumulation shall be kept with the Life membership fund account.

Upon approval of the majority of two thirds (2/3) of Life Members, interest income may be utilized for special projects or as dividend shares commensurate to its contributed membership fund. The fund review and project planning shall be made every three years. A member can check the organization's life membership fund status anytime during business hours for transparency. Council of Life Members shall be organized for the purpose.

Active Life members in the existing roster prior to the approval of this resolution shall be automatically restored as Life Members and will be entitled to all benefits. Non-active Life Members shall be marked IN-ACTIVE as provided below.

Non-honorary Life Members are required to be present in at least one (1) activity of the Organization: General Membership Meeting (once in a year), or Regional Conference (Luzon, Visayas, and Mindanao), or National Conference in a year. Non-active Life Members shall be marked "IN-ACTIVE" in the roster after two consecutive years of in-activity, and all of the benefits except the annual membership dues are forfeited. An organizational service duty in terms of one-hour CPD lecture/ presentation and or event entertainment performance during the National Convention shall serve as a penalty plus an additional fine of Five Hundred Pesos per year of inactivity. The Council of Life Members shall consider a valid reason of in-activity and an amnesty aside from fine and service in accepting back the Life Member. Life Membership is an organization's "special status." For public image and promotion purposes, NAMPAP Inc. may bestow a Life Membership Status to special person/s with a great contribution to the Plumbing Industry or the Organization even if the person is not a member of the organization or Master Plumbing professional. This had reference to an event in 1954 when Albert Einstein quoted in a publication that if he were young again, he would choose to be a plumber than a scientist. The Chicago Plumbers Union offered him an Honorary Membership. An "Honorary Life Membership" shall be awarded to a qualified person(s) as endorsed by an ACTIVE LIFE member and approved unanimously by the National Board of Directors, with the consent of the awardee or information and acceptance of the immediate family member in case of a posthumous declaration. Honorary Life Members shall be included in documents such as publication or souvenir program/ gazette, a "brief and concise" citation shall be written beside the picture of the awardee for awareness of everyone and inspiration of each of the organization members.
